

AGREED MINUTES

A round of negotiations for the conclusion of an Agreement between the Government of the Republic of San Marino and the Council of Ministers of Bosnia and Herzegovina on international transport of passengers and goods by road, were held in San Marino on 4 and 5 October 2012.

The San Marino delegation was headed by **Ms. Savina Zafferani**, Director of Economic Affairs, Department of Foreign Affairs.

The Bosnia and Herzegovina delegation was headed by **Zoran Andrić**, Assistant Minister, Department for Transport, Ministry of Communications and Transport of Bosnia and Herzegovina.

The list of both delegations is attached hereto as Annex 1.

The negotiations were held in a very friendly atmosphere and in a spirit of mutual understanding. Both delegations have expressed their satisfaction for having reached an agreement on the provisions of the draft Agreement. The common draft resulting from the negotiations was initialed and is attached hereto, as Annex 2.


Pending the entry into force of the Agreement, the two delegations have agreed that the competent authorities of Bosnia and Herzegovina shall issue N. 30 permits for occasional and shuttle passenger services to the competent authorities of San Marino for the year 2013.

The delegation of Bosnia and Herzegovina invited the delegation of San Marino to the Joint Committee meeting in Bosnia and Herzegovina after the Agreement enters into force.


